

## Hess Midstream LP Announces Increased Quarterly Distribution

HOUSTON--(BUSINESS WIRE)--Apr. 23, 2021-- Hess Midstream LP (NYSE: HESM) ("Hess Midstream"), today announced that the Board of Directors of its general partner declared a quarterly cash distribution of \$0.4526 per Class A share for the quarter ended March 31, 2021. The distribution represents a 1.2% increase compared to the distribution on the Hess Midstream Class A shares for the fourth quarter of 2020, which equals a 5% increase on an annualized basis. The distribution will be payable on May 13, 2021 to shareholders of record as of the close of business on May 3, 2021.
